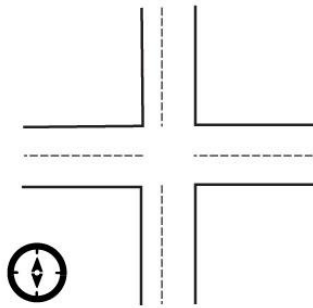
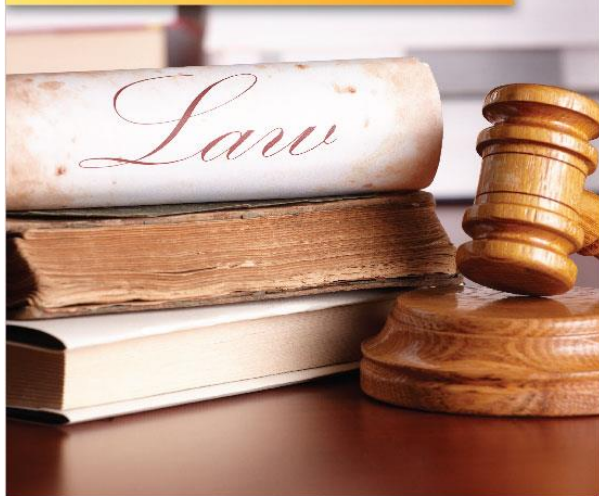

PROTECT THE SCENE

If your vehicle is not blocking traffic, leave it where it is so that the police officer can make an accurate diagram of your location. If you are obstructing traffic, and your vehicle is driveable, move the vehicle away from the obstruction, but leave it as close to the scene as possible.

CALL AN OFFICER

Florida Law requires that the driver of a vehicle involved in an accident resulting in personal injury or death, give notice of the accident to the police department by the quickest means of communication possible. Even where there are apparently no personal injuries, it is recommended and advisable to contact the police department immediately so that an officer can investigate the accident promptly. His official report may greatly assist you later if any claim for injuries or liability is made. Advise the police officer as to how the accident occurred. Never admit that you are wrong, as you may later learn that you are not in the wrong or that the other driver was equally to blame or even more so. Hasty and emotional admissions can prove costly. Fill in thoroughly the information requested in this form and keep it for your records. If you have a camera or cellphone, take photographs of the property damage to the vehicles, the location of the vehicles, and the accident scene which may be helpful in the describing how the accident occurred.
